Those eligible for consideration to receive a two-year scholarship grant must meet all of the following criteria.

Initial	Initial each item to confirm understanding.
	Student must be Sponsored by a current F.A.R. REALTOR® member in good standing with the Fresno Association of REALTORS® and who will provide one of the <u>two</u> required letters of recommendation required with application.
	Two letters of recommendation: one from a Teacher, Advisor or Coach of High School/College/University and the one letter of recommendation from the F.A.R. REALTOR® Sponsor (stated above), must be submitted with the application.
	Student must submit proof of enrollment/admission in a two-year California College/University with the scholarship application.
	Student must be enrolled or accepted as a full-time student (12 or more units) at the time of the scholarship application.
	Student must have maintained a cumulative grade point average of 3.0 or higher from all High Schools/Colleges/Universities attended.
	Official transcripts from all High Schools/Colleges/Universities attended must be submitted with this application.
	Student must be a legal resident of the State of California for at least one year prior to the date of application and have a valid California Driver's license or California State Identification card. Please attach a copy of the CA Driver's License or ID card with the application.
	A typed essay not to exceed 300 words expressing your career objectives must be submitted with the application.
	Student attending a two-year institution may receive a \$1,500.00 scholarship payable to the California College/University for tuition and books. Any major qualifies.
